- The Board of Directors/EESAC meeting of Miami Community Charter School was called to order at 6:41 PM.

# **Administrative Report**

- The Board Members approved the minutes from December 1, 2015 with a correction being made under Business Report the 6<sup>th</sup> bullet: next phases of the construction project we do need to have a public hearing.
- SIP was discussed. Strategies stated continue to be implemented are effective and on target with the direction of the school. The Mid-Year review was submitted on February 18, 2016.
- Title I review audit by the district was done on Tuesday March 1, 2016. All three schools were compliant in all areas except for minor changes on the budget allocation. The budget needs to be revised to reflect the changes on the roster.
- Title I sponsored the parent workshops from February 1-February 8, 2016. These workshops were geared towards orienting the parents on FSA Assessments and the school's academic programs. The workshops were given in English and Spanish.
- The elementary school received recognition money for the 2014-2015 school grade. The
  distribution of the funds were discussed and presented as follows: 60% for
  teachers/administration; 30% for instructional support staff; 10% non-instructional
  support staff. A motion was presented to accept the distribution and all members
  approved the motion; motion passed.
- Mr. Howard Murphy was introduced to the board as a potential board member.

#### **Principal's Report**

- The mid-year assessments were completed by the end of the first semester. Elementary and high school students' performance is comparable or better than the district. The middle school results are lower than the expectations. The Academic Leadership Team and the Literacy Leadership Team have reviewed the data to modify the DI groups and form new tutoring groups.
- The state testing schedule began on March 1 and will continue until May 19, 2016.
- Elementary school's after school tutoring began on February 22 and will continue until April 20, 2016.
- Mid-year notifications of academic concerns were issued. Several meetings were held with
  parents and students to create a plan of action for the students in need of academic
  assistance. In the elementary and middle school 6% of students received the letter, the
  majority of which are levels 1 & 2 ELL students. In high school only four students are failing
  one or more core subjects.
- Across the school and based on Achieve 3000 mid- year report, the percent of College and Career Ready students has increased by 10%.
- Miami Community Charter School is now a certified center to administrate the Microsoft Office Certification exam, Certiport. The board agreed to open this opportunity to the community.
- MDC is now offering the Training for Manufactured Construction Program (TRAMCON) to MCCS students. Students 18 years and older may participate in this free program and students may obtain up to four certificates. Students may continue their education in a four-year college program after receiving these certificates. This is a grant funded program.
- For the second year high school courses, Algebra 1, Biology and Physical Science are embedded in the middle school. Algebra 1 is a graduation requirement and because of the early start in our middle school, currently 203 (81%) of high school students in grades 9 to 12 already have met this requirement.
- The elementary, middle and high school have been selected for a review by the Equal Education Opportunity State Office. The visit will take place on April 2016.
- Miami Community Charter School successfully completed the AdvancED SAC-CASI school accreditation renewal process on February 22 and 23, 2016. The school received an overall score 3 out of 4 for all-inclusive operation. The quality of teaching and learning received 3.2 out of 4 points. In the area of instructional technology the school score was 1.8 points higher than the state average. The visit was completed with several commendations and a few recommendations to increase the parental involvement and the usage of technology in the classrooms.

### **Business Report**

- Construction for the new building is still on-going with waiting periods for permits; construction is estimated at 5 million dollars;
- Suit against Syschovich is still on-going with a hopeful result by the end of the school year;

- Proposal for merging all three schools, increasing the capacity to 800 students and applying for a 15-year contract as well as proposal for the new building site were due to the district today and were delivered yesterday;
- Mr. Gotz discussed that the school is looking at Liberty Health Share as an option to ACA. The board recommends that the option for a presentation from the company to the teachers be done as an alternative to the current insurance plans available;
- With regards to the school bond, the school missed compliance by 2% due to not being up to speed on terms and conditions of the bond. Mr. Gotz is working with the school's financial division to take care of this issue;
- Motion to recommend Mr. Howard to join the board was presented and all board members approved the motion. Mr. Howard will be sent for fingerprinting and board training.
