## **Discussion Items**

-School Improvement Plan (SIP)- SIP is due to the district on 8/31/17, and the follow up meeting will be held on September 11, 2017. Barriers and strategies discussed among the administration and instructional leaders to bring the school grade in the elementary and high school to a "C".

-Classes, Teachers, and Schedules- classes and student/teacher schedules are in place. The elementary is in need of 1 kindergarten teacher and ads have been posted in the Newsleader, Miami Herald, and school's website. Two teachers are awaiting clearance, and 4 teachers need an Out-Of-Field Waiver. The middle school needs a Math teacher, 2 teachers awaiting fingerprinting clearance. Between the Middle and High School 6 teachers require Out-Of-Field Waivers.

-Instructional Materials and Programs discussed. Elementary purchased a new Reading series from Houghton-Mifflin; Journeys and for the Bilingual Cenderos Reading (Spanish). The Bilingual program is teaming up with a sister school in Mexico to collaborate, engage, and interact with the students and teachers. Middle school is using the Houghton-Mifflin Collections Reading series. iReady is being implemented for Reading and Math as an intervention and enrichment program. High school will continue to use Achieve 3000 for Reading and interdisciplinary with Social Studies

-Level-Set/Baseline Assessments- will take place 3x a year: September, December, May. Reading and Math baseline assessments will begin the week of September 6 in all 3 schools. The data will then be disaggregated and student data chats will ensue to help students obtain academic goals.

- -Enrollment- is good with Elementary at capacity of 525 students. Middle currently at 290 and High school at 240.
- -Benefit Package- School will match 2% for 401K, teachers will get a cash bonus for sick/personal days unused, and health insurance has gone up 5% (FL Blue). School is looking into an alternative carrier where there will be no penalty if school breaks contract with FL Blue. -Education Service Provider- looking to bring in One-on-One Company for additional tutoring. The elementary and high schools are eligible to receive a grant to cover the expenses. More information will be forthcoming. Reading and Math district coaches will be assigned to the elementary and high school.
- -Contracts and School Accountability Report/FL

Charter School Alliance- discussion was held to bring a representative to the next board meeting. The board will seek specific details on how best to utilize the organizations services and specific dates to bring on board with contract renewals for the schools. In addition the board agreed to employ the services of a consultant in the process of renewing the contracts. -Professional Development Calendar- discussed and reviewed that the teacher's performance tied to student's performance. PD's for the first quarter will focus on: Data & Accountability, Flipped Classrooms, DI, Engaging Social Behavior, and High Expectations & Information Retention.

## **Business Report**

-Mr. Gotz was not able to attend the meeting, but sent his report which Mrs. Torres read to the board. The report consisted of the appeal to the Department of Education regarding the school's capital outlay which the appeal was lost, but the school will appeal the decision to the appellate court. The school has hired the services of Wasson & Associates to assist with this issue and costs are being shared by the school's co-plaintiff Aspira Charter School. Other items in his report included: sodding and sprinkler system installed to back field in elementary, replacing cafeteria ceiling in elementary and sharing cost with the church, resealing and restriping the elementary parking lot, and all floors in the 3 schools have been stripped and waxed.

### **Public Comments**

Mr. Howard commented that the school needs to pursue its quest in getting an answer on how the learning gains for third graders and the 50% drop in 5<sup>th</sup> grade Math was calculated. Following up with the Charter Alliance consultant to get clarity in their role in assisting the school, but to get the assistance of the person they would recommend to look at the school's data as soon as possible so that the school can strategically plan for this school year in achieving its goal of becoming a "C" or higher
