- Agenda Items
 - School Operation

Jila Rezaie presented the school operation reports;

- The February 2025 FTE was successfully completed. The school total enrollment is 2% over the projected number
- School safety Team has remained unchanged inside the campuses and outside.
- As a member of Miami AI Club-MDC, the school is actively engaged with developing guidelines for using AI in K – 12 education. This is an ongoing task, with several concerns and questions, However, we are preparing to start using AI in school year 2025-2026.

- The school has made notable progress in the areas of academics. The available data from Spring 2025 indicate schools' academic growth.
- Summer Plans are pending until the State budget is released. We have concerns about the loss of the federal funds, including Title I. As of now, we don't have summer school.

• Governmental Affairs

Tony Arza shared with the board information about the state budget, which is dealing with deficit. However, the FEEP has increased by 2%,

2025-2026 School Budget

The 2025-2026 school budget is monitored closely. School budget's current status is strong, however, we may lose the federal grants, including the Title I allocation.

Construction Project

The construction and permits process is moving forward, and we expect completion of the permits no later than June 2025.

• Candidates for board of director's membership

Jila Rezaie introduced two new candidates for the board membership;

Mengi Crespo – Former parent of two Miami Community Charter School's graduates, and current Conflict Resolution designee. Mr. Crespo's professional background is construction and facility

Andres Camacho – Miami Community Charter School's alumni, Class of 2017. Andres' professional background is technology and business, and currently he is a candidate to attend George Town University's law school.
